Celebrating the Republic Day

Even though Sri Lanka was liberated from the British rule on 04th of February 1948, it further remained as a dominion of the British crown. However Sri Lanka became an independent and free state accountable for people with the Republican Constitution of 1972. Therefore, as per the decision of the Cabinet of Ministers no 08/0562/325/004 dated 10.04.2008, all the public institutions should take actions to celebrate the "Republic Day" on 22d of May every year.

Accordingly, you are kindly informed to carry out a programme to celebrate the Republic Day in District Secretariats and the Divisional Secretariats which are under them on 22nd of May paying attention on the following.

- 01. Commencing the event by hoisting the National Flag at 8.30 a.m.
- 02. Delivering a speech of around 15 minutes on the importance of celebrating the Republic Day by the Head of the Institution or a representative of him/her paying attention to the following.
 - Preparation of the draft of the Republican Constitution of 1972 by National State Assembly
 - Appreciation of the contribution of the leaders who pioneered in this task.
 - Sri Lankans becoming an independent nation completely freed from the British rule with the Republican Constitution.
 - Sri Lanka becoming a state accountable for people.
 - Receiving of powers for administrative and economical changes suitable for our country.
