PAYMENT OF AN INTERIM ALLOWANCE TO ACADEMIC, ACADEMIC SUPPORT, ADMINISTRATIVE AND MEDICAL STAFF IN THE UNIVERSITY SYSTEM

Your kind attention is invited to Commission Circular No.855 dated 20th January, 2005 in respect of salary revision granted in terms of Management Services Circular No.25 dated 28th December, 2004.

2. The Cabinet of Ministers at the meeting held on 08th June, 2005 granted approval to pay an Interim Allowance based on the Salary Structure recommended by the Sri Lanka Institute of Development Administration (SLIDA) to Academic, Academic Support, Administrative and Medical staff in the University system with effect from 01.01.2005 until a new salary structure is implemented based on the recommendation of the National Council for Administration.

3. Accordingly, the amount payable per month to permanent employees who are presently holding the posts denoted by salary codes from B-01(a) to B-09, from BS-01 to BS-04, Secretary/UGC, from A-01 to A-04 and from C-01 to C-03 with effect from 01st January, 2005 are indicated below ;
