

## REVISION OF SALARIES OF EMPLOYEES OF STATE CORPORATIONS, STATUTORY BOARDS AND FULLY OWNED GOVERNMENT COMPANIES

Your kind attention is invited to my letter No.UGC/HR/2/9/86 of 17<sup>th</sup> January , 2006 regarding the revision of salaries in 2006.

2. In terms of para 04 of Management Services Circular No.27 of 17.01.2006 addressed to all Secretaries of Ministries, Chairmen of Corporations, Statutory Boards and Fully Owned Government Companies by the Deputy Secretary to the Treasury, a monthly Cost of Living Allowance of Rs.1,000/- will be paid to University Employees with effect from 01.01.2006.
3. This Cost of Living Allowance will be adjusted at the end of every six months according to variation of the Cost of Living Index ie. the allowance will be adjusted by Rs.2.50 per unit of the Cost of Living Index at the end of 30<sup>th</sup> June and 31<sup>st</sup> December of every year.
4. This allowance should not be taken into account for calculation of contributions to Universities Provident Fund, Employees Trust Fund, payment of overtime, Loans and Gratuity etc.
5. Please note that further instructions with regard to implementation of the new salary structure for University Employees based on the recommendations of the National Council for Administration will be issued in due course.
